- Enrollment in FACTS Tuition Management program (see attached information sheet)
- Diocese of Youngstown Federal Credit Union Tuition Loan

Financial Aid and Scholarship

Please note that Financial Aid and Scholarship(s) are available. Families must apply for all aid through FACTS. All past scholarships will only be considered once a family has applied for aid through FACTS. **Deadline is February 26, 2021**

Once a family has applied for AID through FACTS they are able to submit an application for Scholarships. These scholarships are listed on the Cardinalmooney.com website. Applications will be made available to families enrolled in FACTS for the 2021-2022 school year upon request.

Families who apply for AID through FACTS are also registered for the Diocesan Cushwa-Wolsonovich Scholarship application. This \$2000 scholarship is given annually by the Diocese to the needlest of families (that are not receiving Ed Choice).

EdChoice

Students who are currently receiving an EdChoice scholarship can renew the scholarship for the 2021-2022 school year as long as they meet the following requirements:

- They take all required state achievement tests for their grade level:
- They do not have more than 20 unexcused absences for the school year; and
- They do not move out of the school district in which they became eligible.

Parents of renewal students who meet these requirements must complete the EdChoice Scholarship Renewal Form and submit it, along with a copy of a current acceptable proof of address, to Cardinal Mooney.

All families will be responsible for tuition and fees over \$6,000.

Our family understands that our relationship with Cardinal Mooney High School is contractual and contingent upon our adherence to the philosophy, policies, and procedures of the School. I am aware that the Family/Parent Handbook is posted on the school's website or I have received a copy of the School's Family/Parent Handbook that contains the School's philosophy, policies, and procedures and I acknowledge and agree that adherence to the School's philosophy, policies, and procedures is an express condition for admission and continued enrollment by the student. I understand that this agreement is for the 2021-2022 school year, and continued attendance at Cardinal Mooney High School will be determined annually.

It is understood that a parent's obligation to pay the charges for tuition, student fee, and other school fees for the full academic year is unconditional and that no portion of such charges so paid or outstanding will be refunded or canceled notwithstanding the subsequent absence, withdrawal, or dismissal from Cardinal Mooney High School of the student. It is understood that enrollment may be canceled in writing, without penalty prior to August 1. If enrollment is canceled after August 1, parents or guardians financially responsible for the student are obligated to pay a portion of the tuition prorated for the school year.
